## RE: CLETS MISUSE - ALAMEDA COUNTY SHERIFF

Dear Mr. Dominic:

The Electronic Frontier Foundation (EFF) and Media Alliance (MA) request the California Department of Justice (CADOJ) initiate an investigation into the Alameda County Sheriff's Office for potential misuse of the California Law Enforcement Telecommunications System (CLETS). It has come to our attention that sheriff representatives have accessed CLETS to run background checks on volunteers, observers, and journalists that attended Urban Shield-related activities.

Created in 2007, Urban Shield was a law enforcement expo and SWAT/emergency training exercise operated by the Alameda County Sheriff's Office. Increasingly concerned with over-policing and the militarization of law enforcement, many community activists and journalists have attended Urban Shield as observers. According to the Alameda County Sheriff, when these individuals volunteered to attend Urban Shield, their identities were run through CLETS and CRIMS (Consolidated Records Information Management System), which connects Alameda County data to CLETS.

In a memo to CLETS subscribing entities sent in April 2018, you reminded agencies that CLETS is not to be used to query individuals in the media and the Automated Criminal History System (ACHS) is not to be used for licensing, employment, or certification purposes. Furthermore, the CLETS Policies, Practices and Procedures only allow access to CLETS for background checks in very limited circumstances. These permitted situations include screening non-certificated employees or non-teaching volunteers at schools, prospective participants or employees for a public housing program, or visitors to correction facilities. ACHS may be searched prior to approval of a person for a "ride-along" with a law enforcement (i.e. accompanying an officer engaged in real-time

law enforcement activities), however vetting observers at a training exercise or vendor exposition is not one of these limited circumstances.

Community trust in law enforcement relies on transparency and respect for the watchdog roles of civil society and the news media. Accessing the sensitive data of these observers via CLETS would not only be a violation of privacy but also discourages members of the community from participating in oversight activities.

EFF and MA urge the California Department of Justice to review the CLETS journal to identify occasions when these individuals' records may have been accessed. CADOJ should document these incidents as individual misuse investigations and present the resulting findings to the CLETS Advisory Committee at its next meeting. CADOJ should further instruct the Alameda County Sheriff that this use of CLETS is inappropriate. Although the Alameda County Sheriff has ended the Urban Shield activities, CADOJ should instruct the agency to cease all similar background checks on journalists and advocates engaged in oversight roles.
