# <u>Description of Violation</u>

### The Facts of the Alleged Violation:

Police captain Jones appeared remotely at at least two community outreach meetings convened by Shotspotter LLC at their invitation during city-compensated time as a law enforcement officer employed by the City of Oakland.

Shotspotter LLC is a manufacturer of gunshot detection software an predictive analytics for law enforcement agencies and a vendor to the City of Oakland.

Shotspotter LLC convened community meetings in the City of Portland (11+ hours away from Oakland via car) for the purpose of convincing city residents to support the city's adoption of their products.

It was stated that Captain Jones attended the sessions at the invitation of the vendor.

At one of the community meetings, Jones excused himself due to "police business" so it seems reasonable that he was on the job at the time of the meetings and not on vacation or personal time.

Jones appeared on the Zoom screen underneath an OPD logo and in uniform.

There is no direct benefit to the City of Oakland by the adoption of a lucrative contract for Shotspotter LLC by the City of Portland. The interests represented are those of the private vendor.

According to Transparent California, captain Jones billed the City of Oakland over \$60,000 in overtime in calendar year 2021.

## Names and Addresses of Witnesses.

A reporter for Oregon National Public Radio (NPR) was in attendance at one of the community meetings in question. He has not been consulted in the preparation of this complaint.
